OPENED FOR SIGNATURE AT PARIS ON 14 OCTOBER 1994

RECTIFICATION OF THE CONVENTION (CHINESE TEXT)  
AND TRANSMISSION OF THE RELEVANT PROCES-VERBAL

The Secretary-General of the United Nations, acting in his capacity as depositary, and with reference to depositary notification C.N.23.1995.TREATIES-1 of 1 March 1995 by which corrections were proposed to the original of the Convention (Chinese text), communicates the following:

Within a period of ninety days from the date of the above depositary notification, no objection to the proposed correction was received from any of the Parties concerned. Consequently, the Secretary-General has caused, on 30 May 1995, the appropriate correction to be effected in the Chinese text of the original of the Convention. A copy of the corresponding Procès-verbal of rectification, to which is annexed the correction, which also applies to the certified true copies of the Convention, transmitted by depositary notification C.N.338.1994.TREATIES-3 of 1 December 1994 ..... is enclosed.
