ACCESSION BY CROATIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 24 July 1995, the instrument of accession by the Government of Croatia to the above Convention was deposited with the Secretary-General.

In accordance with its article 10 (3), the Agreement will enter into force for Croatia on the ninetieth day after the date of deposit of the instrument, i.e. on 22 October 1995.
