ACCEPTANCE OF THE AMENDMENTS PROPOSED BY ITALY  
TO ANNEX 1 OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary and with reference to depositary notification C.N.416.1994.TREATIES-7 of 22 February 1995, concerning the amendments proposed by the Government of Italy to annex 1 of the above Agreement, communicates the following:

By 22 August 1995, that is to say, on the expiry of a period of six months following the date on which the proposed amendments were communicated by the depositary, none of the Contracting Parties had submitted any objection. Consequently, the amendments have been deemed accepted. In accordance with article 18 (6), they shall enter into force six months after the date of acceptance, i.e. on 22 February 1996.
