CONSTITUTION OF THE UNITED NATIONS INDUSTRIAL  
DEVELOPMENT ORGANIZATION  
CONCLUDED AT VIENNA ON 8 APRIL 1979

WITHDRAWAL BY THE UNITED STATES OF AMERICA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 4 December 1995, the Government of the United States of America deposited with the Secretary-General an instrument of denunciation of the above Constitution. (In this connection, reference is made to depositary notification C.N. 282.1983. TREATIES-11 of 27 September 1983 concerning the ratification by the United States of America of the Constitution.)

In accordance with its article 6 (2), the denunciation will take effect on the last day of the fiscal year following that during which this instrument was deposited, i.e. on 31 December 1996.
