CONVENTION ON ROAD TRAFFIC  
CONVENTION ON ROAD SIGNS AND SIGNALS  
CONCLUDED AT VIENNA ON 8 NOVEMBER 1968

ACCESSION BY UZBEKISTAN

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 17 January 1995, the instrument of accession by the Government of Uzbekistan to the above-mentioned Conventions was deposited with the Secretary-General.

In accordance with article 45 (4) of the Convention on Road Traffic, the Government of Uzbekistan has indicated that it has selected the distinguishing sign "UZ" for display in international traffic on vehicles registered by it.

In accordance with their respective articles 47 (2) and 39 (2), the said Conventions will enter into force for Uzbekistan twelve months after the date of deposit of the instrument, i.e. on 17 January 1996.
