CONVENTION ON THE PROHIBITION OF THE DEVELOPMENT,
PRODUCTION, STOCKPILING AND USE OF CHEMICAL WEAPONS
AND ON THEIR DESTRUCTION
OPENED FOR SIGNATURE AT PARIS ON 13 JANUARY 1993

RECTIFICATION OF THE CONVENTION
(ARABIC AND RUSSIAN TEXTS)
AND TRANSMISSION OF THE RELEVANT PROCES-VERBAL

The Secretary-General of the United Nations, acting in his capacity as depositary and in reference to depositary notification C.N.301.1995.TREATIES-7 of 2 October 1995, by which certain corrections were proposed to the original of the Convention (Arabic and Russian texts), communicates the following:

Within a period of ninety days from the date of the above depositary notification, no objection to the proposed corrections was received from any of the Parties concerned. Consequently, the Secretary-General has caused, on 31 December 1995, the appropriate corrections to be effected in the Arabic and Russian texts of the original of the Convention, which also apply to the certified true copies of the Convention. A copy of the corresponding Procès-verbal of rectification is enclosed.
