INTERNATIONAL TROPICAL TIMBER AGREEMENT, 1994 CONCLUDED AT GENEVA ON 26 JANUARY 1994

RECTIFICATION OF THE AGREEMENT
AND TRANSMISSION OF THE RELEVANT PROCES-VERBAL

The Secretary-General of the United Nations, acting in his capacity as depositary, and with reference to depositary notification C.N.354.1994.TREATIES-9 of 12 January 1995, by which a correction was proposed to the original of the Agreement.

Within a period of ninety days from the date of the above depositary notification, no objection to the proposed correction was received from any of the Parties concerned. Consequently, the Secretary-General has caused, on 12 April 1995, the appropriate correction to be effected in the Arabic, Chinese, English, French, Russian and Spanish texts of the original of the Agreement. A copy of the corresponding Procès-verbal of rectification, to which is annexed the correction, which also applies to the certified true copies of the Agreement, is enclosed.
