AGREEMENT CONCERNING THE ADOPTION OF UNIFORM CONDITIONS
OF APPROVAL AND RECIPROCAL RECOGNITION OF APPROVAL
FOR MOTOR VEHICLE EQUIPMENT AND PARTS
DONE AT GENEVA ON 20 MARCH 1958

ACCESSION BY ESTONIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 2 March 1995, the instrument of accession by the Government of Estonia to the above Agreement was deposited with the Secretary-General.

The said instrument contains the following reservation:

(Original: English)

"... that [the Republic of Estonia] does not consider itself bound by Article 10 of the Agreement."

In accordance with its article 7 (2), the Agreement entered into force for Estonia on the sixtieth day after the date of deposit of the instrument, i.e. on 1 May 1995.
