ACCEPTANCE OF THE AMENDMENTS PROPOSED BY THE
UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND
TO ANNEX 3 OF THE AGREEMENT

The Secretary-General of the United Nations, acting in his capacity as depositary and with reference to depositary notification C.N.414.1994.TREATIES-6 of 13 February 1995 concerning the amendments proposed by the Government of the United Kingdom to annex 3 of the above Agreement, communicates the following:

By 14 May 1996, that is to say, on the expiry of a period of nine months following the expiry of the period of six months following the date on which the proposed amendments were communicated by the depositary, the Government of Slovakia (see depositary notification C.N.339.1995.TREATIES-2 of 30 November 1995) had not submitted any objection. Consequently, the amendments have been deemed accepted. In accordance with article 18 (6), they shall enter into force six months after the date of acceptance, i.e. on 14 November 1996.
