RATIFICATION BY LUXEMBOURG

On 28 October 1996, the instrument of ratification by the Government of Luxembourg of the above Agreement was deposited with the Secretary-General.

In accordance with its article 6 (2), the Agreement will enter into force for Luxembourg on the ninetieth day after the date of deposit of the instrument, i.e. on 26 January 1997.
