On 24 June 1997, the instrument of ratification by the Government of Colombia of the above Agreement was deposited with the Secretary-General.

In accordance with its article XV (2), the Agreement will enter into force for Colombia on the sixtieth day after the date of deposit of the instrument, i.e. on 23 August 1997.
