THE SECRETARY-GENERAL OF THE UNITED NATIONS, acting in his capacity as depositary of the International Covenant on Economic, Social and Cultural Rights, adopted by the General Assembly of the United Nations on 16 December 1966 (Covenant),

WHEREAS it appears that the original of the Covenant (Chinese authentic text) contains an error relating to the use of the term "Covenant",

WHEREAS the corresponding proposed correction has been communicated to all interested States by depositary notification C.N.781.2001.TREATIES-6 of 5 October 2001,

CONSIDÉRANT que la proposition de correction correspondante a été communiquée à tous les États intéressés par la notification dépositaire C.N.781.2001.TREATIES-6 en date du 5 octobre 2001,

WHEREAS by 3 January 2002, the date on which the 90-day period specified for the notification of objections to the proposed correction expired, no objection had been notified,

CONSIDÉRANT qu'au 3 janvier 2002, date à laquelle le délai de 90 jours spécifié pour la notification d'objections à la correction proposée a expiré, aucune objection n'a été notifiée,
