WHEREAS the Administrative Committee of the above Agreement, at its thirty-first session, adopted certain drafting modifications to Regulation No. 115 ("Uniform provisions concerning the approval of: I. Specific LPG (Liquefied Petroleum Gases) retrofit systems to be installed in motor vehicles for the use of LPG in their propulsion system; II. Specific CNG (Compressed Natural Gas) retrofit systems to be installed in motor vehicles for the use of CNG in their propulsion system") (TRANS/WP.29/2005/90),
