REGULATION NO. 122. UNIFORM PROVISIONS CONCERNING THE

ENTRY INTO FORCE OF REGULATION NO. 122<sup>1</sup>

The Secretary-General of the United Nations, acting in his capacity as depositary,  
communicates the following:

Within the period of six months from the date of depositary notification  
C.N.569.2005.TREATIES-1 of 18 July 2005 by which the Secretary-General transmitted to the  
Governments of the Contracting Parties a copy of the above regulation, two Contracting Parties to the  
Agreement notified their disagreement with the draft Regulation<sup>2</sup>. Therefore, in accordance with article  
1(3) of the Agreement, the draft Regulation has been adopted as Regulation No. 122 annexed to the  
above Agreement. The date of entry into force for all Contracting Parties, except Australia and Japan, is  
18 January 2006, pursuant to article 1(4) of the Agreement.
