ENTRY INTO FORCE OF REGULATION NO. 126¹

The Secretary-General of the United Nations, acting in his capacity as depositary,
communicates the following:

Within the period of six months from the date of depositary notification
C.N.558.2007.TREATIES-2 of 9 May 2007 by which the Secretary-General transmitted to the
Governments of the Contracting Parties a copy of the above regulation, two Contracting Parties² to the
Agreement notified their disagreement with the draft Regulation. Therefore, in accordance with article
1(3) of the Agreement, the draft Regulation has been adopted as Regulation No. 126 annexed to the
