WHEREAS the Administrative Committee of the above Agreement, at its thirty-ninth session, adopted certain drafting modifications to Regulation No. 83 ("Uniform provisions concerning the approval of vehicles with regard to the emission of pollutants according to engine fuel requirements") (ECE/TRANS/WP.29/2008/61),
