[ENGLISH TEXT – TEXTE ANGLAIS]

2. Article 7, Section 2 (g), of the Agreement Establishing IFAD is hereby amended to read as follows (the text to be deleted is struck out and the text to be added is underlined):

“Except as the Executive Board shall otherwise decide, the Fund shall entrust the administration of loans, for the purposes of the disbursement of the proceeds of the loan and the supervision of the implementation of the project or programme concerned, to competent national, regional, international or other institutions or entities. Such institutions or entities shall be of a worldwide, ~~or regional~~ or national character and shall be selected in each case with the approval of the recipient. Before submitting the loan to the Executive Board for approval, the Fund shall assure itself that the institution or entity to be entrusted with the supervision agrees with the results of the appraisal of the project or programme concerned. This shall be arranged between the Fund and the institution or agency in charge of the appraisal, as well as with the institution or entity to be entrusted with the supervision”.

2. En vertu de la présente Résolution, l'article 7, section 2 g) de l'Accord portant création du FIDA est modifié comme suit (les parties du texte à supprimer sont barrées et celles à ajouter sont soulignées):

“À moins que le Conseil d'administration n'en décide autrement, le Fonds confie l'administration des prêts à des institutions ou entités nationales, régionales, internationales ou autres

Ces institutions ou entités, à caractère mondial, ~~ou~~ régional ou national, sont sélectionnées dans chaque cas avec l'approbation du bénéficiaire. Avant de soumettre un prêt à l'approbation du Conseil d'administration, le Fonds s'assure que l'institution ou l'entité à laquelle cette surveillance est confiée souscrit aux résultats de l'examen dudit projet ou programme. Les dispositions nécessaires à cet effet sont prises par accord entre le Fonds et l'institution ou l'organisme chargé de l'examen, d'une part, et l'institution ou l'entité à laquelle sera confiée la surveillance, d'autre part".

2. Por consiguiente, se modifica la sección 2 g) del artículo 7 del *Convenio Constitutivo del FIDA* de manera que diga lo siguiente (las palabras que deben suprimirse están tachadas y las que deben añadirse están subrayadas):

“Salvo que la Junta Ejecutiva decida otra cosa, el Fondo confiará la administración de los préstamos, a los efectos del desembolso de la suma correspondiente al préstamo y la supervisión de la ejecución del proyecto o programa de que se trate, a instituciones o entidades nacionales, regionales, internacionales o de otra índole competentes. Estas instituciones o entidades serán de carácter mundial ~~o~~, regional o nacional y en cada caso su selección deberá contar con la aprobación del beneficiario. Antes de someter el préstamo a la aprobación de la Junta Ejecutiva, el Fondo se asegurará de que la institución o entidad a la que se confíe la supervisión está de acuerdo con los resultados de la evaluación del proyecto o programa de que se trate. Esto deberá concertarse entre el Fondo y la institución o el organismo encargado de la evaluación, así como la institución o entidad a la que se confiará la supervisión.”
