PROPOSAL OF CORRECTION TO ANNEX 1, APPENDIX 2,
PARAGRAPH 2.2.4. B) OF THE ATP

The Secretary-General of the United Nations, acting in his capacity as depositary,
communicates the following:

The Working Party on the Transport of Perishable Foodstuffs (WP.11) of the United Nations Economic Commission for Europe has drawn the attention of the Secretary-General to an error in the English text of Annex 1, appendix 2, paragraph 2.2.4 (b) of ATP and requested that the correction be transmitted to Contracting Parties for acceptance (ECE/TRANS/WP.11/226, para. 43).

The text of the proposed correction is contained in Annex II of the report of WP.11 on its sixty-eighth session (22-25 October 2012) (ECE/TRANS/WP.11/226).
