The Annex to this notification contains the proposed corrections to the authentic Chinese text, which should be considered in addition to the proposed corrections already circulated on 7 August 2013.

In accordance with the established depositary practice, unless there is an objection to effecting a particular correction from a Signatory State or a Contracting State, the Secretary-General proposes to effect in the said authentic text of the Amendment to Annex B of the Protocol, the proposed corrections to the Chinese authentic text.

Any objection should be communicated to the Secretary-General no later than 18 October 2013.
