On 18 July 2016, the President of the Republic, in concert with the Cabinet, issued Government Decree No. 3-2016 extending the state of emergency for another 30 days, since the circumstances that gave rise to Government Decree No. 2-2016 continued to exist.

Government Decree No. 3-2016
Guatemala City, 18 July 2016

THE PRESIDENT OF THE REPUBLIC

WHEREAS on 21 June 2016 the President of the Republic, in concert with the Cabinet, issued Government Decree No. 2-2016 declaring a 30-day state of emergency in the municipality of Jerez, in Jutiapa department, as a result of the landslides caused by heavy rainfall in the municipality and the department, which had damaged roads, housing, schools, health facilities and other infrastructure and impaired the provision of essential services and production activities and human development; and Government Decree No. 2-2016 was ratified by the Congress of the Republic through Decree No. 31-2016 of 23 June 2016,

WHEREAS the circumstances that gave rise to Government Decree No. 2-2016 continue to exist, making it necessary to extend the state of emergency, which as stipulated in the decree was to expire on 20 July 2016,

THEREFORE, in exercise of the powers conferred on him by articles 1, 2, 3, 138, 139 and 183(f) of the Political Constitution of the Republic of Guatemala and on the basis of articles 1, 2, 6, 14, 15, 25, 28, 31, 32 and 36 of Decree No. 7 of the National Constituent Assembly (Public Order Act),

IN CONCERT WITH THE CABINET,

DECREES AS FOLLOWS:

Article 1. Extension. The state of emergency contained in Government Decree No. 2-2016 of 21 June 2016 and ratified by Decree No. 31-2016 of the Congress of the Republic on 23 June 2016 is hereby extended for another 30 days.

Article 2. Justification. The state of emergency is being extended because the circumstances that gave rise to Government Decree No. 2-2016 of 21 June 2016 continue to exist.

Article 3. Convening of Congress. Within three days, the Congress of the Republic of Guatemala shall convene to consider, ratify, amend or reject this Government Decree. A detailed report of the events that occurred and the measures that were taken during the emergency shall be submitted to Congress in due course, together with the corresponding justifications for extending the state of emergency, as provided in article 32 of the Public Order Act.
