Upon instructions from my Government, I am writing to you with reference to our letter no. 2016/11235663 dated 21 July 2016, through which we had brought to your attention that on 20 July 2016, a State of Emergency was declared by the Government of Turkey for a duration of 90 days, in accordance with the Turkish Constitution (article 120) and the Law No. 2935 on State of Emergency (article 3/1b).

In this framework, I wish to inform you that the State of Emergency has been extended for a period of three months starting from 19 October 2016 at 01.00 AM by Decision no. 1130 dated 11 October 2016. The English translation of the said Decision is enclosed herewith.

I would therefore underline that this letter constitutes further information for the purposes of article 4 of the International Covenant on Civil and Political Rights.
