The Permanent Mission of Ecuador to the United Nations presents its compliments to the United Nations Secretariat and hereby informs it that, owing to illegal mining activity in Zaruma Canton, El Oro Province, where tunnels or cavities have been dug without regard for any technical standards, causing subsidence and collapse of material inside the mines, and in order to protect the safety of the residents of Zaruma Canton and to address the impact and the collapse of structures on the surface, the Government of the Republic of Ecuador, on the basis of the powers conferred by the Constitution, has declared a state of emergency in Zaruma Canton, El Oro Province, pursuant to Executive Decree No. 158¹ of 15 September 2017.

The Permanent Mission of Ecuador to the United Nations has the honour to inform the Secretariat that the following rights set out in the International Covenant on Civil and Political Rights have been derogated from with the issuance of Executive Decree No. 158:

• Article 12, paragraph 1: "Everyone lawfully within the territory of a State shall, within that territory, have the right to liberty of movement and freedom to choose his residence." (freedom of movement);
