- Supreme Decree No. 090-2017-PCM was issued on 10 September 2017.¹
- The Supreme Decree extends the state of emergency for a period of thirty (30) calendar days, with effect from 11 September 2017, in the District of Tumán, Province of Chiclayo, Department of Lambayeque.
- During the state of emergency established by the aforementioned Supreme Decree, the rights relating to liberty and security of person, inviolability of the home and freedom of assembly and movement within the territory, recognized in articles 9, 17, 21 and 12 of the International Covenant on Civil and Political Rights, are suspended.
- The state of emergency was declared in order to ensure the maintenance of public order and to prevent acts of violence or any criminal offense that could be committed in that area.
