INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS NEW YORK, 16 DECEMBER 1966

THAILAND: NOTIFICATION UNDER ARTICLE 4 $(3)^{1}$

The Permanent Mission of Thailand to the United Nations presents its compliments to the Executive Office of the Secretary-General of the United Nations and, with reference to the former's Note no. 56101/672 dated 3 July B.E. 2557 (2014), has the honour to inform the latter that Thailand has lifted the invocation of Martial Law as well as the orders of the National Council for Peace and Order relevant to rights derogated as referred to in the above-mentioned Note and that, in accordance with Paragraph 3 of Article 4 of the International Covenant on Civil and Political Rights (ICCPR), any and all derogations of rights covered under the Covenant made pursuant to the said Covenant shall henceforth be terminated.

The Permanent Mission of Thailand would therefore appreciate it if the Executive Office of the Secretary-General could notify other States Parties to the Covenant of the foregoing information, as required by Article 4 of the Covenant.

The Permanent Mission of Thailand to the United Nations avails itself of this opportunity to renew to the Executive Office of the Secretary-General of the United Nations the assurances of its highest consideration.
