PERU: NOTIFICATION UNDER ARTICLE 4 (3) 1

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

The Permanent Mission of Peru to the United Nations presents its compliments to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat, and, in accordance with article 4 of the International Covenant on Civil and Political Rights, bearing in mind what is stated in note verbale LA 41 TR/2017/IV-4/Peru/1, dated 1 March 2017, has the honour to report the following:

- By Supreme Decree No. 080-2023-PCM, dated 13 July 2023, the Government of Peru extended the state of emergency declared in Corredor Vial Sur Apurímac-Cusco-Arequipa (Apurímac-Cusco-Arequipa Southern Road Corridor) and Corredor Vial Interoceánica Sur (Southern Interoceanic Road Corridor), including the five hundred (500) metres adjacent to each side of these roads. Furthermore, the Government of Peru declared a state of national emergency on Carretera Panamericana Norte (Northern Pan-American Highway), Carretera Panamericana Sur (Southern Pan-American Highway), Carretera Central (Central Highway), Via Los Libertadores, Fernando Belaúnde Terry Highway, Federico Basadre Highway, Carretera Binacional (Puno-Tacna) and on the Departmental or Regional Road Networks, including the five hundred (500) metres adjacent to each side of these road networks.
- The extension and implementation of the state of emergency on the highways and road networks specified in the preceding paragraph is for a period of 30 calendar days, starting on July 14, 2023.
- The reason for the extension and for the implementation of the state of emergency is to preserve internal order and guarantee the fundamental rights of the population. During the state of emergency, the constitutional rights relating to liberty and security of person, inviolability of the home and freedom of assembly and movement in the territory, included in articles 9, 12, 17 and 21 of the International Covenant on Civil and Political Rights, are suspended.
