PERU: NOTIFICATION UNDER ARTICLE 4 (3)<sup>1</sup>

The Permanent Mission of Peru to the United Nations presents its compliments to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat and, in accordance with article 4 of the International Covenant on Civil and Political Rights, bearing in mind what is stated in note verbale LA 41 TR/2017/IV-4/Peru/1, dated 1 March 2017, has the honour to report the following:

• By Supreme Decree No. 081-2024-PCM, published on 2 August 2024, the Government of Peru extended the state of emergency, for a period of sixty (60) calendar days, from 4 August to 2 October 2024 in the following districts:

- In the district of Uchuraccay of the province of Huanta in the department of Ayacucho, only the communities of Ccarapa and Ccano should be considered in the extension of the State of Emergency.
- The state of emergency was extended in view of the continuity of terrorist activities and the commission of other illegal activities in the aforementioned areas, and in order for the Armed Forces to be able to continue to deploy military operations and actions to progressively pacify said areas. During the state of emergency, the constitutional rights relating to liberty and security of person, inviolability of the home and freedom of assembly and movement in the territory, included in articles 9, 12, 17 and 21 of the International Covenant on Civil and Political Rights, are suspended.

The Permanent Mission of Peru to the United Nations takes this opportunity to convey to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat, the renewed assurances of its highest consideration.
