INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS NEW YORK, 16 DECEMBER 1966

ECUADOR: NOTIFICATION UNDER ARTICLE 4 $(3)^{1}$

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

The Permanent Mission of Ecuador to the United Nations presents its compliments to the Office of Legal Affairs, United Nations Secretariat and, pursuant to notes verbales No. 4-2-79/2024 and No. 4-2-97/2024, by which it informed the Office of Legal Affairs of the entry into force of Executive Decrees No. 318 and No. 351, of 2 July and 8 August 2024, respectively, has the honour to inform it of the issuance and entry into force of Executive Decree No. 377, of 30 August 2024, by which the President of the Republic, Daniel Noboa Azín, has extended, for an additional 30 days, the state of emergency in the Provinces of Guayas, Los Ríos, Manabí, Orellana, Santa Elena and El Oro and in the Camilo Ponce Enríquez canton of Azuay Province, owing to serious internal unrest, under the same terms as those set forth in Executive Decrees No. 318 and No. 351.

Thus, pursuant to Executive Decree No. 377, the following rights remain temporarily suspended:

- The right to inviolability of the home
- The right to inviolability of correspondence
- The right to freedom of association and assembly
- The right to freedom of transit, with the exceptions established in the above-mentioned decrees.

Consequently, the rights enshrined in the International Covenant on Civil and Political Rights that have been temporarily suspended under Executive Decree No. [377] are those contained in articles 12, 17, 21 and 22 of that treaty.

Pursuant to article 1 and the final provision of Executive Decree No. 377, the extension of the state of emergency shall be in effect for 30 days beginning on 30 August 2024.

Pursuant to article 4, paragraph 3, of the International Covenant on Civil and Political Rights, the Permanent Mission of Ecuador respectfully requests that the Office of Legal Affairs, United Nations Secretariat, inform the other States parties to the Covenant of the issuance and entry into force of Executive Decree No. 377 and of the rights that remain temporarily suspended.

The Permanent Mission of Ecuador to the United Nations takes this opportunity to convey to the Office of Legal Affairs, United Nations Secretariat, the renewed assurances of its highest consideration.
