• Through Supreme Decree No. 104-2024-PCM¹, dated 2 October 2024, a state of emergency was declared, for a period of 60 calendar days, from 3 October to 1 December 2024, in the population centres of Yanamonte and Carhuahuran in the District of Uchuraccay, Province of Huanta, Department of Ayacucho; and in the population centre of Cochabamba Grande in the District of Cochabamba Grande, Province of Tayacaja, Department of Huancavelica. In addition, the state of emergency was extended for the same period in the following districts and population centres:

During the state of emergency, the constitutional rights relating to liberty and security of person, inviolability of the home, and freedom of assembly and movement in the territory, included in articles 9, 12, 17 and 21 of the International Covenant on Civil and Political Rights, are suspended.
