The Permanent Mission of Peru to the United Nations presents its compliments to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat, and, in accordance with article 4 of the International Covenant on Civil and Political Rights, bearing in mind what is stated in note verbale LA 41 TR/2017/IV-4/Peru/1, dated 1 March 2017, has the honour to report the following:

By Supreme Decree No. 104-2025-PCM, issued on 10 August 2025, the state of emergency declared in the districts of Pangoa and Río Tambo, Province of Satipo, Department of Junín, has been extended for a period of 60 calendar days, starting on 14 August 2025.

In addition, as from the above-mentioned date, the Supreme Decree repeals the following regulatory provisions:

- Supreme Decree No. 085-2025-PCM, Supreme Decree extending the state of emergency declared in the districts of Manitea, Kimbiri and Cielo Punco, Province of La Convención, Department of Cusco, and in the district of Samugari, Province of La Mar, Department of Ayacucho;
- Supreme Decree No. 090-2025-PCM, Supreme Decree extending the state of emergency declared in the districts of Anco and Unión Progreso, Province of La Mar, Department of Ayacucho, and in the districts of Megantoni, Kumpirushiato, Echarate, Villa Virgen and Villa Kintiarina, Province of La Convención, Department of Cusco;
- Supreme Decree No. 099-2025-PCM, Supreme Decree extending the state of emergency declared in the districts of Ayna, Santa Rosa, Anchihuay and Río Magdalena, Province of La Mar, Department of Ayacucho.

Furthermore, as from 14 August 2025, a state of emergency has been declared for a period of 60 calendar days in the following districts of the Province of La Convención, Department of Cusco, and of the Province of La Mar, Department of Ayacucho:

This measure has been taken in response to illicit drug trafficking activities by criminal gangs and organizations affecting internal order. It provides for the restriction of the exercise of the constitutional rights relating to the inviolability of the home, freedom of movement through national territory, freedom of assembly, and liberty and security of person, enshrined in paragraphs 9, 11, 12 and 24 (f) of article 2 of the Constitution of Peru, and in articles 9, 12, 17 and 21 of the International Covenant on Civil and Political Rights.

The Permanent Mission of Peru to the United Nations takes this opportunity to convey to the Treaty Section of the Office of Legal Affairs, United Nations Secretariat, the renewed assurances of its highest consideration.
