#### *Declarations and Reservations*

*(Unless otherwise indicated, the declarations and reservations were made upon ratification, acceptance, approval or accession.)*

#### **AZERBAIJAN**

"In accordance with Article 13, paragraph 5 of the Intergovernmental Agreement on Dry Ports, the Republic of Azerbaijan does not consider itself bound by the provisions of Article 13 relating to conciliation."

"The Republic of Azerbaijan declares that the provisions of the Intergovernmental Agreement on Dry Ports shall not be applied by the Republic of Azerbaijan in respect of the Republic of Armenia."

The Republic of Azerbaijan declares that it does not guarantee the implementation of the provisions of the Agreement in its territories occupied by the Republic of Armenia (the Nagorno-Karabakh region of the Republic of Azerbaijan and its seven districts surrounding that region), until the liberation of those territories from the occupation and complete elimination of the consequences of that occupation..."

#### **CHINA**

In accordance with the Basic Law of the Hong Kong Special Administrative Region of the PRC and the Basic Law of the Macao Special Administrative Region of the PRC, the Government of the People's Republic of China decides that the Agreement applies to the Macao Special Administrative Region of the PRC, and unless otherwise notified by the Government, shall not apply to the Hong Kong Special Administrative Region of the PRC.

#### **IRAN (ISLAMIC REPUBLIC OF)**

"...the implementation of the provisions of Article 13 of the Agreement is subject to fulfilment of the requirements of Article 139 of the Constitution of the Islamic Republic of Iran..."

#### **MYANMAR**

"In accordance with Article 10 and Article 13, Paragraph 5 of the Agreement, the Republic of the Union of Myanmar does not consider itself bound by the provisions of Article 13 relating to conciliation."

#### **THAILAND**

"In accordance with Article 10 and Article 13, paragraph 5 of the Agreement, the Kingdom of Thailand does not consider itself bound by the provisions of Article 13 relating to conciliation."

#### **TÜRKİYE**

"The Government of the Republic of Turkey does not consider itself bound by the provisions of Article 13 relating to reconciliation."
