

**2. INTERNATIONAL CONVENTION RELATING TO ECONOMIC STATISTICS, SIGNED
AT GENEVA ON 14 DECEMBER 1928, AMENDED BY THE PROTOCOL SIGNED AT
PARIS ON 9 DECEMBER 1948**

Paris, 9 December 1948
