

13. b) Amendment to the Convention on Access to Information, Public Participation in Decision-Making and Access to Justice in Environmental Matters

Almaty, 27 May 2005

ENTRY INTO FORCE: 20 April 2025, in accordance with article 14(4) of the Convention which stipulates: "...Amendments to this Convention other than those to an annex shall enter into force for Parties having ratified, approved or accepted them on the ninetieth day after receipt by the Depositary of notification of their ratification, approval or acceptance by at least three fourths of these Parties. Thereafter they shall enter into force for any other Party on the ninetieth day after that Party deposits its instrument of ratification, approval or acceptance of the amendments".
