RESERVATIONS AND DECLARATION ENTERED UPON SIGNATURE

Reservation on article 2 paragraph 4

The Government of the Federal Democratic Republic of Ethiopia declares its reservation to the provision of Article 2 paragraph 4 of the Agreement where all the financial transactions of the Global Fund shall be in accordance with the laws of Ethiopia.

Reservation on article 2 paragraph 8

The Government of the Federal Democratic Republic of Ethiopia reserves the implementation of Article 2 paragraph 8 on the exemption from value added tax of goods, supplies, materials, equipment, property, services or funds that may be exported or sold or transferred to another person or entity in the country to be in accordance with the laws of Ethiopia.

Reservation on article 3 paragraph 3

The Government of the Federal democratic Republic of Ethiopia declares that it does not consider itself bound by the provision of Article 3 paragraph 3 of the Agreement.

Reservation on article 4 paragraph 2(b) and (f)

The Government of the Federal democratic Republic of Ethiopia reserves the application of the provision of Article 4 paragraph 2(b) and (f) to the representative of the Global Fund only.

Reservation on article 3 paragraph 1(f) Article 4 paragraph 2(d) and (f)

The Government of the Federal democratic Republic of Ethicpia does not consider itself bound to give comparable rank in respect of immunities and privileges as accorded to

diplomatic missions under Article 3 paragraph 1(f), Article 4 paragraph 2(d) and (f) of the Agreement.

Reservation on article 4 paragraph 4

The Government of the Federal democratic Republic of Ethiopia declares its commitment to the provision of Article 4 paragraph 4 of the Agreement with the reservation that it will be applied to foreign nationals only.

RESERVATION AND DECLARATION ENTERED UPON RATIFICATION

Reservation on Article 7 paragraphs 2-6

The Government of the Federal Democratic Republic of Ethiopia does not consider itself bound by the provisions of Article 7 paragraph 2-6 of this Agreement. All differences arising out of the interpretation or application of the present Agreement shall be resolved pursuant to Article 7 paragraph 1 of the Agreement.

Declaration on the nature of immunities and privileges

The Government of the Federal Democratic Republic of Ethiopia declares that the immunities and privileges granted to representatives of states, officials and other individuals und entire Agreement apply only to the acts done in the exercise of their official functions.
