## [TRANSLATION<sup>2</sup> — TRADUCTION<sup>3</sup>]

In accepting the present Convention we declare that the Socialist Republic of Czechoslovakia reserves the right, under Article 19, paragraph 1, to refuse to recognise a divorce or a legal separation between two spouses who at the time of the divorce or legal separation were nationals of the Socialist Republic of Czechoslovakia and of no other State, and a law other than that indicated by the rules of Czechoslovak private international law was applied, unless the result reached is the same as would have been reached by applying the law indicated by those rules. In conformity with Article 24 we declare that the Convention shall not apply to a divorce or to a legal separation obtained before the date on which it entered into force for the Socialist Republic of Czechoslovakia.

The Socialist Republic of Czechoslovakia wishes to state that the provisions of Article 29 of the Convention on the recognition of divorces and legal separations, concluded at The Hague on June 1, 1970,<sup>4</sup> under which any State may apply the Convention to all territories for the international relations of which it is responsible, are out of date and in contradiction with the United Nations Declaration on the granting of independence to colonial countries and peoples (Resolution No. 1514/XV of December 14, 1960).<sup>5</sup>
