NOTIFICATION by Togo

By a communication received on 23 October 1962, the Government of Togo has notified the Secretary-General, pursuant to Section B (2) of article 1 of the above-mentioned Convention, that it has extended its obligations under this Convention by adopting alternative (b) of Section (B) (1) of that article, that is to say, "events occurring in Europe or elsewhere before 1 January 1951".
