AMENDMENT<sup>1</sup> TO THE STATUTE<sup>2</sup> OF THE INTERNATIONAL ATOMIC ENERGY AGENCY.  
 APPROVED AT VIENNA BY THE GENERAL CONFERENCE OF THE AGENCY AT THE  
 FIFTH REGULAR SESSION, 4 OCTOBER 1961

The first sentence of subparagraph A-3 of article VI should read as follows :

“ The General Conference shall elect twelve members to membership on the Board of Governors, with due regard to equitable representation on the Board as a whole of the members in the areas listed in subparagraph A-1 of this article, so that the Board shall at all times include in this category three representatives of the area of Latin America, three representatives of the area of Africa and the Middle East and a representative of each of the remaining areas except North America. ”

<sup>1</sup> In accordance with the provisions of Article XVIII of the said Statute, the Amendment came into force for all members of the International Atomic Energy Agency on 31 January 1963, by the acceptance thereof by two-thirds of the said members following the approval by the General Conference of the Agency.
