## DEFINITIVE ENTRY INTO FORCE

In accordance with paragraph 1 of article 64, the Agreement entered into force definitively on 27 December 1963, the date by which Governments representing twenty exporting countries having 82.4 per cent of total exports in the year 1961, as specified in Annex D, and Governments representing thirteen importing countries having 82.3 per cent of world imports in the same year as specified in the same Annex, had deposited their instruments of ratification. Following is a list of the twenty exporting and thirteen importing countries on behalf of which the instruments of ratification were deposited with the Secretary-General of the United Nations on the dates indicated:
