

No. 696. AGREEMENT PROVIDING FOR THE PROVISIONAL APPLICATION OF THE DRAFT INTERNATIONAL CUSTOMS CONVENTIONS ON TOURING, ON COMMERCIAL ROAD VEHICLES AND ON THE INTERNATIONAL TRANSPORT OF GOODS BY ROAD. SIGNED AT GENEVA, ON 16 JUNE 1949¹

(To take effect on 1 January 1965.)

With the following statement :

[TRANSLATION — TRADUCTION]

However, the Government of Italy regards its denunciation as limited only to those Parties to the three Draft Conventions, who have adhered to and ratified — or in future may adhere to and ratify — the Customs Convention of May 18, 1956 on the Temporary Importation for Private Use of Aircraft and Pleasure Boats,² the Customs Convention on the Temporary Importation of Commercial Road Vehicles done at Geneva on 18 May 1956,³ and the Customs Convention of January 15, 1959, on the International Transport of Goods under Cover of TIR Carnets.⁴
