

No. 881. CONVENTION (No. 87) CONCERNING FREEDOM OF ASSOCIATION AND PROTECTION OF THE RIGHT TO ORGANISE. ADOPTED BY THE GENERAL CONFERENCE OF THE INTERNATIONAL LABOUR ORGANISATION AT ITS THIRTY-FIRST SESSION, SAN FRANCISCO, 9 JULY 1948<sup>1</sup>

13 April 1964

DECLARATION by the UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND made under article 35, paragraphs 4 and 7, of the Constitution of the International Labour Organisation<sup>2</sup> stating that it accepts without modifications on behalf of and in agreement with the Government of Barbados the obligations of the Convention in respect of this territory.

This declaration supersedes the declaration made by the Government of the United Kingdom, which was registered on 13 March 1961.<sup>3</sup>

DÉCLARATION du ROYAUME-UNI DE GRANDE-BRETAGNE ET D'IRLANDE DU NORD faite conformément aux paragraphes 4 et 7 de l'article 35 de la Constitution de l'Organisation internationale du Travail<sup>2</sup>, selon laquelle il accepte sans modification, au nom et avec l'accord du Gouvernement de la Barbade, les obligations de la Convention à l'égard de ce territoire.

Cette déclaration remplace la déclaration faite par le Gouvernement du Royaume-Uni, enregistrée le 13 mars 1961<sup>3</sup>.
