AGREEMENT¹ ON TECHNICAL AND SCIENTIFIC COOPERATION BETWEEN THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES AND THE GOVERNMENT OF THE REPUBLIC OF INDONESIA

Considering their common interest in the promotion and development of their science and technology,

Believing that mutual cooperation in the field of scientific activities will greatly enhance the welfare of their states and peoples, and

Recognizing the immeasurable benefits to be derived by both states from closer technical and scientific cooperation,

Referring to the Basic Agreement on Economic and Technical Cooperation between the Government of the Republic of the Philippines and the Government of the Republic of Indonesia signed on the 8th day of August 1974,² both Governments have agreed as follows:

Article I. Both Governments shall endeavour to cooperate and support each other, within the limits of their capabilities, on technical and scientific matters that may mutually be agreed upon. Such technical and scientific cooperation shall be on a basis of equal partnership and mutual benefit.

Article II. In order to achieve the objectives referred to in Article I above, the following activities shall be undertaken:

- a. exchange of information on scientific, technical, organizational and management matters, as well as information on existing training facilities in scientific, technical and industrial institutions;
- b. exchange of advisors, experts, technicians, scholars and fellows;
- c. provide practical training in the fields of industry and trade;
- d. conduct other forms of technical and scientific cooperation which might be deemed necessary by both Governments.

Article III. The implementation of the activities set forth in the preceding Article shall be carried out through separate contracts or agreements concluded between appropriate Philippine and Indonesian organizations in the public as well as in the private sector. Such separate agreements shall specify the nature and extent of the rights and obligations of the parties to such agreements.

Article IV. The payment of expenses incurred in carrying out the technical and scientific cooperation activities provided in this Agreement shall be established in each individual case through contracts or agreements as mentioned in Article III.

Article V. In accordance with their existing laws and regulations, both Governments shall grant to the citizens of either contracting country sent to the other pursuant to this Agreement, all assistance necessary to facilitate their work and assure the successful performance of their task.

Article VI. The provisions of this Agreement shall also apply to all persons, who, upon the effectivity of this Agreement, are already in territories of both Governments for any of the purposes mentioned in Article II of this Agreement.

Article VII. Both Governments agree to hold from time to time consultations between officials of the two Governments for the purpose of according sympathetic consideration to representations made by either Government with respect to:

- a. the implementation of this Agreement,
- b. any other matters pertaining to the sound development of technical and scientific cooperation between the two countries.

Both Governments agree that the first consultation between officials of the two Governments be held as soon as possible after the signing of this Agreement.

Article VIII. Both Governments agree to grant to nationals or legal entities of the other country treatment in investments and other economic activities relative to technical and scientific cooperation no less favourable than that accorded to any other country, with due regard to their respective bilateral as well as multilateral commitments.

This Agreement shall not preclude the consideration by either Government of preferential arrangements in economic activities relative to technical and scientific cooperation between and/or among ASEAN countries.

Article IX. This Agreement shall come into force provisionally on the date of signing. It shall definitively come into force after an exchange of notes to that effect between the two Governments and shall remain in force for a period of one year following the exchange of notes.

Upon expiry of this period the Agreement will automatically remain in force for further periods of one year each.

After the initial period of one year, either Government may:

- a. propose in writing to the other Government the revision of the present Agreement to be mutually discussed and agreed upon;
- b. terminate the present Agreement by giving three months prior written notice to the other Government.

Any revision or termination of this Agreement shall be without prejudice to any rights or obligations which have accrued or which have been incurred prior to the effective date of such revision or termination.

Article X. This Agreement supersedes the Agreement on Technical and Scientific Cooperation concluded between the Government of the Republic of the Philippines and the Government of the Republic of Indonesia on 30th May, 1969.

IN WITNESS WHEREOF, the undersigned being duly authorized thereto by their respective Governments, have signed this Agreement.
