

***Treaty Event – Focus 2005: Responding to Global Challenges
New York, 14-16 September 2005***

***Daily Report
Thursday, 15 September 2005***

- Conditions for entry into force of *United Nations Convention against Corruption, 2003* were met today. The Convention will enter into force on 14 December 2005.
- The *Amendment to articles 24 and 25 of the Constitution of WHO, 1986* entered into force today, 15 September 2005.
- *International Convention for the Suppression of Acts of Nuclear Terrorism, 2005* - 27 signatures.
- 31 states and the European Community undertook 67 treaty actions relating to 25 treaties.
- 15 states participated at the level of Head of State or Government.
- 15 states participated at the level of Minister for Foreign Affairs.
- A total of 38 signatures and 29 ratifications/accessions/acceptances/consent to be bound.
