DAILY REPORT

Tuesday, 19 September 2006

11 States undertook 18 treaty actions today. Of that number, three States participated at the level of **Head of State or Government** and six States participated at the level of **Minister for Foreign Affairs**. There were a total of 10 signatures, three ratifications and five accessions. A breakdown of the actions by treaty appears below.
