



***2011 Treaty Event:
Towards Universal Participation and Implementation***

Daily Report

Monday, 26 September 2011

The Treaty Section today registered **sixteen (16) treaty actions** by eight (8) Member States. Four (4) Member States participated at the **ministerial level**, and four (4) at the level of **Permanent Representative** to the United Nations.

There were a total of two (2) accessions, five (5) ratifications, eight (8) signatures, and one (1) consent to be bound. Furthermore, an instrument of ratification to the Convention on the Safety of Spent Fuel Management and on the Safety of Radioactive Waste Management, deposited with the International Atomic Energy Agency (IAEA) was deposited by Chile.
